teen MENTAL HEALTH FIRST AID FUNDING OPPORTUNITY APPLICATIONS DUE FEBRUARY 9

ABOUT teen MENTAL HEALTH FIRST AID

teen Mental Health First Aid (tMHFA) is an evidence-based training program for teens in grades 10-12, or ages 15-18. Through the program, teens learn how to recognize warning signs that a friend may be experiencing a mental health challenge. It also teaches them how to talk to a friend about mental health, seek help from a trusted adult, and access resources.

FUNDING FOR FALL 2024

Missouri's Department of Mental Health and Missouri's Department of Elementary and Secondary Education are providing funding for tMHFA. These grants will cover the cost of training instructors (a value of \$1,700 per person) and provide required program manuals for the teen participants (a value of \$12.95 per student) for the Fall 2024 semester.

APPLICATION TIMELINE AND IMPORTANT DATES

JANUARY 15 - FEBRUARY 9

Selected organizations will be notified. Spring instructor training dates are: April 30th-May 2nd or June 3rd-5th.

MARCH 1

PROGRAM REQUIREMENTS

The following requirements must be met to qualify for participation in the program:

- The site must be a school or youth-serving organization in Missouri.
- The site must be able to implement tMHFA for teens in grades 10-12, or ages 15-18 in Fall semester 2024. At this time, training for grade 9 and post-secondary students is not permitted.
- The site must designate a site administrator who will serve as the key contact and oversee implementation. The site administrator will need to provide reports on the number of students trained after each course.
- The site must be able to meet the criteria of implementing tMHFA with fidelity:
 - If teaching at a school, the course should be taught to an entire grade level of students (not individual classes) in the school. If teaching at a youth-serving organization or program, the course should be taught to an entire group of students at the youth-serving organization or program.
 - Before delivering tMHFA to students, the participating school or organization will have approximately 10% of staff at the site trained in Youth Mental Health First Aid. K-12 public schools can register for free YMHFA courses [here](#). Others can email teen@mhfamissouri.org to get staff trained.
 - The school or organization offering tMHFA will have a mental health professional on-site while the course is being taught and safety protocols in place to ensure student safety. This includes a process in place to respond to a teen who is in distress and indicates they would like to be seen.
 - tMHFA consists of three 90-minute sessions or six 45-minute sessions. The course will be taught in classes of approximately five to 30 teens on non-consecutive days. The program should not be taught in large, assembly-style sessions.
